The Shareholders of the Company or their proxies who will attend the Meeting are required to submit copies of their Identity Cards (Kartu Tanda Penduduk) or other forms of identification either authorize or who are authorized to the registration officer of the Company's before entering the meeting room. Shareholders in the Collective Custody shall display the Written Confirmation for Meeting (KTUR), which may be obtained through the member of IDX or Custodian Bank.
